APPLICATION FOR DAY CARE PLACE

Operating Hours: Monday to Friday, 8 am to 6pm (10 hours each day), except bank holidays, 48 weeks per annum.

Children attending the nursery are eligible for the Free Early Education Entitlement (FEEE) Grant. It is a government grant which enables children aged three and four to have free nursery education from the term after their third birthday and before they begin school. We are a London Borough of Waltham Forest approved FEEE provider.

At present a child is entitled to a 570 hours of Free Early Education per annum which is equivalent to 15 hours per week over 38 weeks. It is our policy that children must be able to attend the nursery 5 days a week to access the full 15 hours.

As our nursery is open 48 weeks a year, parents of children attending the nursery beyond the 38 weeks (term time) will be required to pay full nursery fees without any discount.

We are happy to split places but those places would have to be considered Children Centre places and would need to be paid for.

We now offer day care term time only 38 weeks of the year from 8:00 to 3.30pm

Monthly Cost Payable One Month In Advance
